Call to order at 4:02 pm

Roll call: Members sign into chat for attendance

Approval of minutes from the last meeting of 02/21/23-Stacy Force made a motion to approve the minutes. Dawn Howard seconded the motion.

Guest speakers: Tiffany Papagno - Education Coordinator for Mid-Cities Women's Clinic. Racheal Moore, RN-Sr. Clinical Director for Mid-Cities Women's Clinic.

Presentation on the Empower Program which is in place at Trinity & KEYS High Schools. This is a mentorship program to walk side by side with teens who are parents or expectant parents (male or female) providing support, encouragement, and education. Educational topics include; healthy relationships, labor & delivery process, postpartum period, connecting with resources for child care, medical care, WIC, & higher education, Lunch is provided for the students at school, diapers, wipes, and other supplies are available to them as needed. The purpose of this mentorship is to provide a judgment free support system where teen parents can feel supported and empowered to parent their child. Statistics show that 50% of teen mothers do not graduate from high school. The support of the Empower program increases their confidence to parent a child and achieve their educational goals. Empower mentors work closely with the school nurse and school counselors to serve these students.

Discussion: Could this be made available to our Junior High students as well? The Health Services Coordinator will assess the need in this area.

Narcan Protocol Update

-Narcan protocol is in place on all campuses, SRO's and nurses have been trained. Standing order for Narcan is in place. 48 boxes of 2 doses of Narcan were ordered from UT San Antonio nursing school. 24 boxes have been received. At this time Narcan is in the emergency medication box on elementary campuses and SRO's carry Narcan at secondary campuses.

When the 2nd shipment of Narcan is received, nurses will have it in their emergency medication box. Awaiting confirmation on when administrators will be trained.
